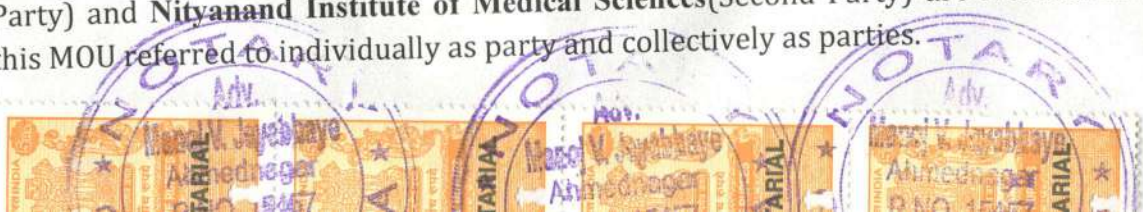

MEMORANDUM OF UNDERSTANDING

Milk Dairy, Post: M.I.D.C, Ahmednagar-414 111, Maharashtra, India of the First Party and Nityanand Institute of Medical Sciences ,Pachane, Pune is the Second Party. It is clearly and distinctly understood and acknowledged that this MOU has been executed by and Nityanand Institute of Medical Sciences, Pachane, Pune. Therefore, all the rights and obligations as provided in this MOU shall be exercised / performed by NIMS. Dr. VithalraoVikhePatil Foundation's College of Nursing DVVPF's CON (First Party) and Nityanand Institute of Medical Sciences(Second Party) are hereinafter in this MOU referred to individually as party and collectively as parties.



IT IS HEREBY AGREED by and between the parties hereto as follows.

1. OBJECT AND PURPOSE:

- ii. Exchange of documentation, research material, publication and the information on the field of mutual interest including any research collaborations at either of the institutes of the parties as per the policies of both Universities of the parties.
- iii. Development, Organization and hosting of joint Research symposia, conferences, workshops and meetings.
- iv. Exchange of information, advice and assistance relating to areas of mutual interest; student and faculty exchange.
- v. Other activities of mutual benefit for Dr.VithalraoVikhePatil Foundation's College of Nursing and Nityanand Institute of Medical Sciences
- vi. However it is agreed between the parties that the estimation of the financial implications and the availability of appropriate financial and administrative support will be decided in compliance with the applicable laws, rules, regulation and as per the policies of both the parties.

2. POTENTIAL BENEFITS:

The potential benefits to the parties will be related to development, organization and hosting of joint conferences and workshops including to seek, provide and exchange expert advices and guidance to enrich the academic excellence.

It is agreed that a frame work of preliminary scheduled activities like student exchange programme, organize conference and expert lecture series etc. will be worked upon mutually by the parties in writing separately. The decided delivery timelines like student exchange programme, expert lecture series and organization of a conference during academic session shall be scheduled in its desired framework by mutually agreed and written agreements or documents as decided by the parties prior to commencing of every such activity.



3. TERMS AND CONDITIONS:

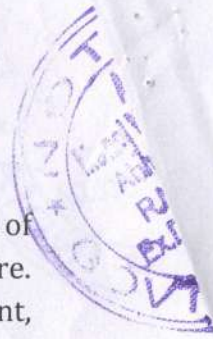
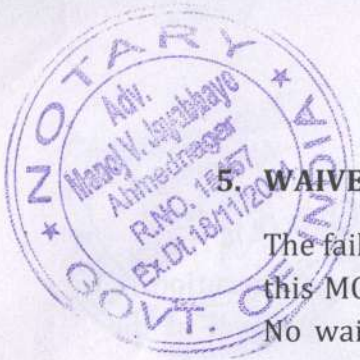
The parties to this MOU mutually agree –

- i. This MOU shall be effective for a period of 5 years from the date of execution.
- ii. All future programs and activities shall be subject to the approval of the parties and based on mutually agreed written MOU.
- iii. That the availability of appropriate financial and administrative support will be given in compliance with all applicable laws, rule and regulation as well as policies of the parties.
- iv. That each program and activity arising from this MOU, shall be executed through a separate written MOU and/or agreement, between the duly authorized representatives of both parties. The said MOU and/or agreement shall describe all of the terms and conditions relating to the program and/or activity and its execution/implementation including any other related details as mutually agreed by the parties, and all financial obligations excluding the grant of any benefit to, or the imposition of any obligation on the parties.
- v. Each parties shall bear all the expenses of their students in connection of travelling, lodging and boarding during student exchange programme as per the rules and regulations of the parties.
- vi. That every academic year at least one event (Seminar/Conference/workshop) shall be planned and may be executed by both parties based upon mutual agreement between the parties in writing.
- vii. The parties to this MOU shall appoint its own representative with respect to each activity as under this MOU and notify the other party of the same. The said representative shall be directly responsible for overseeing the implementation and operation of the activity. The representative shall act as the main point of contact with respect to that activity.

4. NOTICES :

- a. Any notice or other information required to this MOU will be communicated by a party to the other party through registered mode of service only.
- b. In case of any change to communication address of Parties, the same shall be communicated to the other side within 7 days, to the change of that address.

Any notices, consents, claims, requests or other communication required or permitted to be given under any of the provision of this MOU shall be in writing either through facsimile or by mail to be delivered by hand or by post /courier against acknowledgement. The notice shall be deemed to have been received on the next day of transmission if sent through email and five days of date of dispatch if sent through regular post. The notice aforementioned shall be given in attention of the concerned person at the following address (or to such address any party).



5. WAIVER:

The failure of either party to enforce compliance with any term and condition of this MOU shall not constitute a waiver of such term or condition in the future. No waiver by either Party, of any provision of this MOU shall, in any event, become effective unless the same shall be in writing and such waiver shall be effective only in the specific instance described and for the purpose that the waiver is given.

6. MISCELLANEOUS:

No addition or change in the terms of this MOU shall be effective or binding on either of the parties unless reduced to writing and executed by the duly authorized representative of each of the party.

7. ASSIGNMENT:

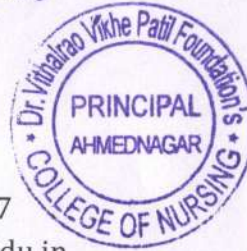

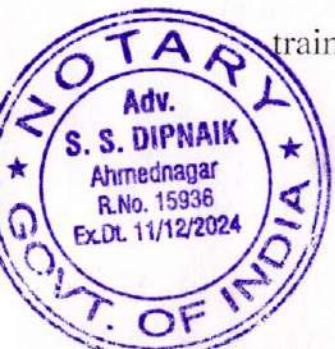
With reference to the subject noted above, you are hereby

Terms and conditions

1. To send the students in Health Center/Kai. B.D. Hospital in
group wise.



2. It will be the responsibility of the Institution to appoint the teacher (Tutor). The tutor has to monitor the students. The Tutor is to remain present on each and every occasion.
3. During the training period of the students, the concerned institution has to make the necessary arrangement in respect of the duties of the students in consultation of the Medical Officer or Chief Medical Officer of the Health Center.
4. Upon granting permission of training, but before starting the training, the concerned responsible office bearer of the said institution has to furnish an agreement in the prescribed format duly signed by him. It will be also the responsibility of the concerned institution to take approval for the said training from the competent officer of the Maharashtra Nursing Council.
5. The said permission is for only temporary period of one year (2023-24) and it is necessary for the institution to renew the said permission for every year.
6. During the agreement period, the necessary amount of fees of next three months, as an advance, is required to be deposited with the Municipal Corporation prior to 10th day of the first month. Only after deposit of the said amount, the students be sent for training.
7. The concerned institution has to take care that during the training period there should not be any effect on the patient



or on the hospital administration on account of behavior of the student.

8. During the training period if the student leaves the hospital or roaming outside of the hospital, then the institution will be held responsible.
9. For training in the Ahmednagar Mahanagar Palika's Urban Public Health center (U.P.H.C) an amount of Rs.5/- per students per day and for getting experience in Kai. D.B. Hospital an amount of Rs.10/- per students per bed and Rs. 20/- per students for two beds are being charged.

Each Party will consult with the each other before disclosing information relating to operational matters covered by this Memorandum of Understanding, as required by law, and each Party will only disclose that information in accordance with the law.

The Term and Condition

1. The term of this Agreement shall be for a period of five (5) years from the date of signing.
2. This Memorandum of Understanding may be varied from time to time by mutual agreement between the Parties. With each variation, a new document including the variation(s) will be produced, agreed, and then signed and distributed by the Parties.
3. This Agreement may be terminated as follows:

In the event Snehalaya, Ahmednagar shall mutually agree that this Agreement may be terminated on terms and date stipulated therein.

This Agreement may be terminated by either party with or without cause by delivering a written notice of termination to the other party at least thirty (30) days prior to such early termination

Execution

This Agreement and any amendments thereto shall be executed in duplicate copies on behalf of Snehalaya, Ahmednagar by an official of each, specifically authorized by its respective Board to perform such executions. Each duplicate copy shall be deemed an original, but both duplicate originals together constitute one and the same instrument.

1.2 E- WASTE – GOVERNING RULES:

These rule are applicable to every producer, consumer or bulk consumer, collection center, dismantler and recycler of e- waste involved in the manufacture, sale, purchase and processing of electrical and electronic equipment.

1.3 DEFINITIONS AND INTERPRETATION:

1. Electronic Waste (E-Waste) – The term E- Waste will refer to the below mentioned electrical and electronic waste for the purpose of the Agreement which includes:
